- · signal their intentions to other road users
- ride on the correct part of the road they are using
- pass side roads, parked or slower moving vehicles
- · turn right and left on a major and minor road
- take the correct carriageway lane when they need to (eg at roundabouts)
- · demonstrate a basic understanding of the Highway Code.

Notes

- You are giving consent for your child to participate in activities conducted on the public highway.
- Young riders are expected to remain in the activity from beginning to end, unless they have to leave early. If the
 rider has to leave early, or is being collected by someone other than the parent/guardian, the parent/guardian
 must advise the ride leader, club official of the details of the arrangement, including who will be collecting the
 rider.
- Any young riders who persistently misbehave or put others in danger will be asked to leave the sessions and will not be allowed to attend in future.
- It is the parent's/guardian's responsibility to ensure that his/her child's bike is in a safe condition to ride. All riders must wear a cycling helmet at all times throughout the activity.

Please ensure you make a note of any medical conditions your child has or you feel the ride leader, club official should know about (in Section 3). If you have any concerns about your child participating in any form of physical activity, please consult your GP before giving permission for your child to take part in the activities.
